### **CHAIR'S STATEMENT**

Our second year of operation has been a very strange one: very busy from June 2019 to March 2020, followed by a period of reflection and restructuring as we slammed into COVID-19 lockdown.

Our aim remains to accelerate the transition to a fair and healthy carbon neutrality within Greater Cambridge.

It is becoming clear that we can play an important role in the Greater Cambridge low carbon "eco-system"; as a source of well informed, ambitious ideas for local councils and NGOs; as independent voices cutting through the greenwash; and as a supportive community for our Members.

In creating our resources, events and articles we aim to tap into the wealth of local expertise and concern about climate change. We use our contacts and advisors to help us identify and publicise key opportunities and threats. We help our volunteer Members undertake research projects of interest to them, and then disseminate the results.

Our approach is to be well informed and supportive of those trying to do the right thing, while challenging greenwash and inaction. We are clear that there is a huge need for this, which has only been amplified by the imperative of achieving a Green Recovery from COVID-19

We have restructured our website to make our resources and activities clearer.

Some of the founding committee members are standing down for FY 20/21, and we thank them for their energetic work to date. We hope to build on their achievements


# Cambridge Independent

(Ongoing)

Carbon Neutral Cambridge has continued to write a monthly column in the Cambridge Independent newspaper. This is an excellent way both to raise our profile and to help promote our ideas to a wider audience. Topics covered in the past year ranged from CPCA's transport policy to the ways in which we could stimulate a Green Recovery from covid. The articles are also published on our blog.

# UCL Global Citizenship Programme (June 2019)

Carbon Neutral Cambridge was again invited by UCL to organise an event as part of their Global Citizenship Programme. Students developed ideas about how different institutions and campaign groups might respond to calls for increased climate actions. This culminated in presentations before a panel from Camden Council and DEFRA. Feedback from this event is shown on page 5.



# The Climate Coalition Net Zero Campaign (Ongoing)

June 2019, as part of the national campaign, together with Cambridge Carbon Footprint, we organised about 50 participants from a variety of Cambridge organisations to join us in Westminster, lobbying the Cambridge MP Daniel Zeichner. Within days the UK Government set a legally binding Net Zero Target

# Zero Carbon Futures Report

(August 2019)

We published our report on the findings and recommendations from our May 2019 Zero Carbon Futures Symposium, exploring how Local Plans could accelerate the transition to Net Zero. It was then presented and discussed at the Climate and Environment Advisory Committee of South Cambs District Council and shared with key officers, community groups and others. The Greater Cambridge Shared Planning Service told us that this has been "really useful for us in helping us to start framing our thoughts on the role of planning in responding to the climate emergencies and net zero carbon The report also formed one of the background documents for our Net Zero Carbon Study."

With help from the charity Client Earth, we sent copies to the key people at all 105 UK councils with Local Plans in preparation, to help them fulfil their legal duty to ensure that these were in line with the requirements of the Climate Act. Client Earth told us they are "pleased with the apparent increase in the priority placed on this issue [ie getting to net zero] by planners and councillors"

# Climate Emergency Conference: Net Zero Construction

(March 2020 - subsequently postponed)

We organised a major conference in conjunction with the Cambridge Forum for the Construction Industry (CFCI). This aimed to engage the local Construction Industry in supporting ambitious decarbonisation measures in the new Local Plan. We had an inspiring line up of speakers and 200 paying participants booked, but sadly it had to be postponed at the last minute due to the Covid-19 pandemic. It is hoped to hold the event online later in the year. The original schedule is shown on the rear cover.

# Combined Authority Climate Commission (Ongoing)

Since its inception, Carbon Neutral Cambridge has been calling for the establishment of a Climate Commission for the Cambridgeshire & Peterborough Combined Authority (CPCA).

On 29 November 2019 the CPCA board announced that it was establishing this, 6 months later announcing Baroness Brown of Cambridge as Chair. We welcome this appointment but call for substantive and urgent action.

## **Consultations** (Ongoing)

We responded to 5 consultations during the year (all are available on our website)

- Greater Cambridge Sustainable Design and Construction Supplementary Planning Document
- Cambridgeshire County Council's Climate Strategy
- The CPCA consultation on the Local Transport Plan
- The Future Homes Standard
- Greater Cambridge Local Plan: Issues and options.

## Other projects

### Carbon emissions

We analysed BEIS data and prepared a report on Carbon Emissions in Greater Cambridge region 2005-2017, which was used by South Cambridgeshire District Council in preparing their climate strategy.

### **CPCA Draft Local Transport Plan**

We analysed the CPCA's disappointing draft Local Transport Plan, published a commentary on it and ran a public event discussing it.

### **Minimum Energy Efficiency Standards**

In October 2019 we used our Cambridge Independent column, website and contacts in the Councils to raise awareness of the neglected Minimum Energy Efficiency Standard (MEES). This rules that from April 2020, homes with EPC F&G cannot be let without registering for an exemption and investing £3.5K in efficiency improvements. To demonstrate the scale of the problem we used the open access EPC dataset to plot the location of all rented EPC F&G homes



We are pleased to see that 6 months later the South Cambridgeshire Climate Strategy explicitly promised to "support good private landlords and to take enforcement action against the bad ones."

We will encourage them to fulfil this promise, and will be looking for similar enforcement action by Cambridge City Council

We also plan to help Cambridge City Council's Climate Strategy, aiming to increase the level of ambition and specificity.

This offers a satisfying way for those with an interest in housing or planning make a real difference to Greater Cambridge's future carbon emissions.

# Local Carbon Emissions & Trajectory (ongoing)

Our website contains an analysis of carbon dioxide emissions in the Greater Cambridge region for 2015-16. We are keen to continue updating this and to explore carbon reduction trajectories. Lots of fun for those that like playing with numbers!

## Other opportunities

The Agricultural sector provides big opportunities for reducing emissions and carbon sequestration, and there are some important "farmer-led" initiatives around. We are exploring ideas for what to do and welcome input from those with an interest in sustainable agriculture and habitats.
